

2021 CIWEM Subscription Information

CIWEM's subscription year runs from January to December. Each year you will receive an CIWEM subscriptions invoice via your MyCIWEM account, detailing your CIWEM annual subscription and any fees for external registrations you hold with CIWEM. In accordance with Bye-Law 34, ('All annual subscriptions shall be due and payable in advance on the first day of January in each year') your membership subscription is due for payment on **01 January 2021**.

Payment Options

Pay Online: Subscriptions can be paid online via the MyCIWEM members' area of our website using a credit/debit card.
