

## **2024 CIWEM Subscription Information**

CIWEM's subscription year runs from January to December. Each year you will receive an CIWEM subscriptions invoice via you MyCIWEM account, detailing your CIWEM annual subscription and any fees for external registrations you hold with CIWEM. In accordance with our Regulations, ('All annual subscriptions shall be due and payable in advance on the first day of January in each year') your membership subscription is due for payment by the **01 January 2024**.

## **Payment Options**

Pay Online: Subscriptions can be paid online via the MyCIWEM members' area of our website using a credit/debit card.
